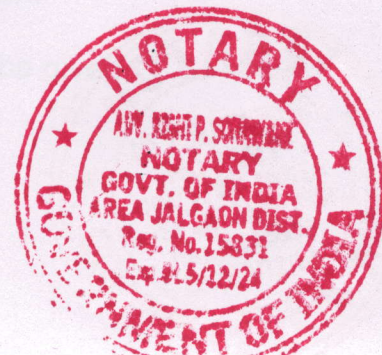
**Subject:-** Permission and Approval to schools under Right to Children to free and compulsory education Act, 2009 under section 18 and Right of Children to free and compulsory education Act 2011 section 11 sub section (4).

Respected Sir/ Madam.

Based on proposal submitted by you on Dated 17.3.2020 and communication made by you and inspections of school.

I, Education Officer (Primary) Zilla Parishad Jalgaon Dated 01.04.2020 to 31.3.2022 for the period of three years for the standard 1<sup>st</sup> to 6<sup>th</sup> ( self-financed school) to Kids Gurukul International School Sawkheda Shiwar, Jalgaon Taluka and District Jalgaon.( name of school including address) granting temporary permission.

Above permission is granted on fulfillment of following terms and conditions.



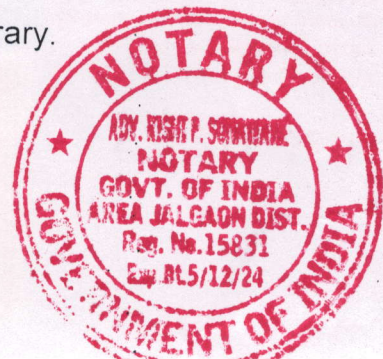
- 1) We are not bound to grant any permission & extension for further class from standard 8<sup>th</sup> onwards.
- 2) School will be bound to Right of Children to free and compulsory education Act 2009 and Maharashtra Right of Children to free and compulsory education Act 2011.(copy is annexed)
- 3) School will provide admission to children of socially weaker and exempted section and 1<sup>st</sup> class and out of said class of students upto 25% will be given/allotted and till completion of primary education will be provided and the same will be applied to pre primary.
- 4) As scheduled in above para 3 the school will be provided with special bank account as per provisions of section 12 (2).
- 5) Administration and School will not charge any capitation fees and will not compel any parents or student to participate in such scrutiny proceedings.
- 6) No children will be denied from admission on non submission or providing of proof of birth certificate, caste, religion, place of birth etc.
- 7) i) No child will be kept in the same class in which he was studying or will not be removed till completion of his primary education.
  - ii) No child will be punished physically or mentally.
  - iii) No child will be compelled to pass out of any exams of any organization till completion of primary education.
  - iv) Every child completing primary education will be given





certificate under rule 23.

- v) Physically Challenged / Privilege children will be admitted as per norms prescribed.
- vi) Teacher will be appointed on minimum qualification as prescribed under section 23(1) of the Act as also that, the said teacher should qualify the required qualification within 5 years from the date of such appointment.
- vii) Appointed teacher will comply with all condition as imposed under section 24(1) of the act.
- viii) No Teacher shall implicate himself or herself in any private coaching will be confirmed by the school administration.
- 8) School Education Committee rules will be followed for education and syllabus as decided by the committee.
- 9) School will admit students based on , Sub section 19 according to facilities provided and available.
- 10) As inspected under section 19 of of the act , school will follow the same and on last occasion of inspection following things were available in school as follows.
- . Area of school premises
  - . Total Builtup area of school
  - . Total area of Playground of school
  - . Number of Classrooms
  - . Office and Storage room and Room of Principal
  - . Separate toilets for girls and boys and arrangement of water and cleanliness and good health
  - . Drinking water facilities
  - . Kitchen for noon hours cooking food
  - . Study room and reading room facilities, Lab Equipment articles / sports and games equipment and articles and library.



- .Reading articles availability

- 11) No sub-division or other classes which are not permitted will be allowed to be operated in school premises or any other places.
- 12) Building and premises of school and play ground will be exclusively used for education purpose or skill development.
- 13) School is being administered under the act of 1860 and (1860 section 21) or as per Bombay Public Trust Act 1950 and rules by the trust.
- 14) School is not working for the purpose of any profit margin to any person, class or any organization.
- 15) School shall be audited from the registered auditor and audit report shall be made and submitted to the district education officer once a year
- 16) School code of your education institution is **RTE0109123** and shall be put on every communication made with the office.
- 17) School shall provide information/reports/audits as and whenever demand by Deputy Director/District Education officer and shall follow the pre-condition for approval and for removing the lacunas and shall follow guidelines given by the state authority and regional tribunal of education.
- 18) Trust shall take care of renewal and registration of trust.
